A Churchill Fellowship offers Australian citizens the remarkable opportunity to travel and investigate a topic or an issue that they are passionate about.

It is for anyone who feels they have exhausted alternatives within Australia and would like to see what other countries are doing successfully in a similar space to inspire new ideas, innovation and excellence.

The high international regard for Churchill Fellowships provides a pathway for Fellows to access expertise from around the world, expanding their knowledge and experience for the benefit of Australian society. There is a high level of visibility and credibility associated with being a Churchill Fellow.

No prescribed qualifications are required in order to apply for a Churchill Fellowship. The subject of the proposed project is limitless provided a benefit to Australia is evident and a willingness to share the knowledge gained with Australia is displayed.

Over 100 Fellowships (including more than 30 Sponsored Fellowships) are awarded across Australia each year.

The duration of a Churchill Fellowship is typically four to eight weeks, however, slightly shorter or longer itineraries can be considered if justified.

The value of each Fellowship varies, however, the average award is worth well in excess of \$25,000. These funds cover airfares, a variable allowance for travel in-country, assistance with overseas living expenses and possible assistance with the cost of conference, training or lesson fees that relate to your project.

Churchill Fellows are ordinary Australians who have a passion to further develop their expertise to enrich Australian society.

ELIGIBILITY

To be eligible to apply for a Churchill Fellowship you must:

- be an Australian Citizen over the age of 18;
- not be enrolled in tertiary studies directly related to the topic of your proposed project;
- have experience in and commitment to the field of your project;
- have a project of 4 weeks to approximately 8 weeks that requires overseas investigation;
- be willing to disseminate the results of your investigations with the broader Australian community; and
- not have been awarded a Churchill Fellowship in the past.

If you meet the Churchill Trust [selection criteria](#) and successfully complete the [interview process](#) you could be awarded a Churchill Fellowship.

Please note All applications must be made using the online application form, download the 2016 Online Application Guide at churchilltrust.com.au/application-process/how-to-apply/. Postal applications can only be considered in exceptional circumstances at the discretion of the Trust's CEO. Contact the Trust's National Office to discuss your situation.

HISTORY

The Churchill Trust was established in 1965 following the death of Sir Winston Churchill.

The Trust was formed with the principal objective of perpetuating and honouring Sir Winston Churchill's memory by the awarding of Memorial Fellowships to be known as 'Churchill Fellowships'.
